

How to Get a Refund from Delta Airlines

Whether you need a full cash refund after Delta cancelled your flight, want to use the 24-hour rule, or need to convert an eCredit back to cash, this complete guide covers every refund scenario with step-by-step instructions and the exact phone numbers to use. How Do I Request a Refund from Delta Airlines?

To request a Delta refund: cancel your flight online at delta.com under 'My Trips,' submit a refund form at delta.com/refund, or call the Refunds Department at +1-800-847-0578. For refundable tickets and Delta-cancelled flights, always request a cash refund explicitly — not an eCredit.

Step 1. Go to delta.com/refund or call **+1-800-847-0578** (Refunds Department).

Step 2. Have your booking confirmation (PNR), ticket number (starts with 006), and payment method details ready.

Step 3. State clearly you are requesting a **cash refund to your original payment method** — not an eCredit.

Step 4. If Delta cancelled your flight, mention this explicitly — you are legally entitled to a cash refund under DOT regulations.

Step 5. Note your refund request reference number for follow-up.

Step 6. Allow 7–10 business days for credit card refunds and up to 20 days for debit cards.

Does Delta Give Refunds on Non-Refundable Tickets? Non-refundable Delta tickets receive a full Delta eCredit — not a cash refund — when cancelled voluntarily. You receive a full cash refund if Delta cancels your flight, if you cancel within 24 hours of booking, or if you have a documented qualifying emergency. Call +1-800-847-0578 for refund

assistance.

The term 'non-refundable' refers only to cash refunds — not to the ticket's value. A non-refundable ticket preserves full value as a Delta eCredit when cancelled outside the 24-hour window. If Delta is responsible for the cancellation, the ticket becomes fully refundable to cash regardless of what the fare says. Always ask for cash when Delta cancels — call +1-800-847-0578.

Can I Get a Cash Refund Instead of a Delta eCredit?

Yes — in three situations: (1) Delta cancelled your flight — legally entitled to cash refund. (2) You cancel within 24 hours of booking. (3) You purchased a refundable ticket. For any of these, call +1-800-847-0578 and say explicitly: 'I want a cash refund, not an eCredit.'

When Delta cancels your flight, the airline's automated system sometimes defaults to issuing an eCredit. You have a legal right to a cash refund and must ask for it explicitly. Call +1-800-847-0578 and reference 'DOT refund regulations for cancelled flights.' If you already accepted an eCredit after a Delta-cancelled flight, call within a reasonable timeframe — they can still convert it to cash in most cases.

How Long Does a Delta Refund Take?

Delta refunds to credit cards take 7–10 business days. Debit card refunds take up to 20 business days. eCredits are issued instantly. If you haven't received your refund after the expected timeframe, call +1-800-847-0578 with your refund reference number.

- **Credit card (Visa, Mastercard, Amex, Discover):** 7–10 business days.
- **Debit card:** Up to 20 business days — bank clearing adds additional time.
- **Delta eCredit:** Immediate — visible in your SkyMiles account within minutes. • **Check (cash purchases):** Up to 20 business days — mailed to address on file. • **Refund not arrived?** Call +1-800-847-0578 with your cancellation confirmation number.

How Do I Get a Refund for a Delta Cancelled Flight?

If Delta cancels your flight, call +1-844-994-3876 or +1-800-847-0578 and say: 'My flight was cancelled by Delta and I am requesting a full cash refund to my original payment method.' You are legally entitled to a cash refund — not just an eCredit — under U.S. DOT regulations.

DOT regulations are clear: when an airline cancels a flight, the passenger is entitled to a full refund to the original form of payment. This applies to all fare types including Basic Economy. Delta is required by law to offer this option. If a Delta agent pushes back, ask for a supervisor and reference 'DOT

refund regulations for cancelled flights.' You can also submit a refund request at delta.com/refund, or escalate to the DOT at airconsumer.dot.gov if unresolved.

What Is Delta's 24-Hour Refund Policy?

Delta's 24-hour refund policy allows any passenger to cancel within 24 hours of purchase for a full cash refund — all fare types including Basic Economy — provided the flight departs at least 7 days after the booking date. Cancel at delta.com or call +1-844-994-3876 immediately to use this free cancellation window.

The 24-hour rule is a U.S. federal DOT regulation. The window begins at the moment your payment is confirmed. This applies to ALL fare types — even Basic Economy, which otherwise has zero refund value. If you realize you've made a booking error, act immediately — call +1-844-994-3876 right now. International callers use +1-844-213-9506.

How Do I Check My Delta Refund Status?

Check your Delta refund status by calling +1-800-847-0578 with your refund reference number or original booking PNR. For eCredits, log in to your SkyMiles account at delta.com — they appear immediately after cancellation. Credit card refunds appear on your statement within 7–10 business days.

When you cancel and request a refund, Delta provides a refund reference number in your confirmation email. If you did not receive one, call +1-800-847-0578 with your original PNR and passenger name — agents can locate your refund record and provide a status update. International passengers can call +1-844-213-9506 for refund status inquiries.

Can I Get a Refund for Delta Baggage Fees?

Yes — Delta baggage fees are refundable when: Delta cancels your flight, your bag was lost and never recovered, or you cancelled within 24 hours of booking. Baggage fee refunds are not automatic — call +1-844-994-3876 to request them separately.

Baggage fee refunds require an explicit request. If your flight was cancelled by Delta, any pre-paid checked bag fees should be refunded with your ticket — verify this when you call. For lost bags, Delta's liability for domestic flights is up to \$3,800 per passenger. File a claim at the airport immediately and follow up with +1-844-994-3876.

How Do I Get a Refund for a Delta Refundable Ticket?

Refundable Delta tickets can be cancelled at any time before departure for a full cash refund to your original payment method. Cancel online at delta.com under 'My Trips' or call +1-844-994-3876. Refunds process within 7–10 business days for credit cards.

Refundable fares offer complete flexibility — a refundable ticket can be cancelled even 10 minutes before departure for a full cash refund. If you accidentally receive an eCredit instead of a cash refund on a refundable ticket, call +1-800-847-0578 and request correction. The Refunds team can identify your fare type and issue the correct cash refund.

What If Delta Denies My Refund Request?

If Delta denies a refund you believe you are owed, escalate by: (1) asking for a supervisor at +1-800-847-0578, (2) submitting a formal complaint at delta.com/feedback, (3) filing a complaint with the DOT at airconsumer.dot.gov, or (4) disputing the charge with your credit card company.

Credit card chargebacks are a strong last-resort — especially for DOT-mandated refunds after airline-caused cancellations. Contact your card issuer and explain the airline cancelled the service and refused the required refund. DOT complaints require airlines to respond within 60 days. Always try direct resolution with Delta first at +1-800-847-0578.

Can I Get a Refund on a Delta Vacation Package?

Delta Vacation package refunds depend on the specific package terms. The flight portion follows Delta's standard policy; hotel and car rental components have their own cancellation terms. For Delta Vacations refunds, call +1-844-213-9506 rather than the general customer service number.

Delta Vacations packages bundle flights, hotels, and sometimes car rentals. Each component may have a different refund policy. The flight portion follows Delta's standard cancellation policy (eCredit or cash depending on fare type). Hotels may have their own cancellation deadlines — check your package terms before cancelling.

How Do I Get a Refund for a Delta SkyMiles Award Ticket? Cancel your Delta award ticket at delta.com or by calling +1-844-994-3876. Miles are redeposited to your SkyMiles account within 3–5 business days. Any cash taxes or fees paid are refunded to your original payment method within 7–10 business days.

Miles are redeposited directly to your SkyMiles account — no extra steps needed. Cash taxes and carrier fees are refunded to the original payment method. Diamond Medallion members get free redeposit of miles. Other Medallion tiers may have a small redeposit fee depending on ticket type. Call +1-844-994-3876 for current redeposit fee information by status level.

What Is the Delta Refund Phone Number?

The dedicated Delta Refunds Department number is +1-800-847-0578 (Mon–Fri 8 AM–7 PM ET). For

24/7 refund assistance, call the general line at +1-844-994-3876. For SkyMiles award ticket refunds, call +1-844-994-3876. International callers use +1-844-213-9506.

Knowing the right number saves time. For standard refund requests and eCredit-to-cash conversions, +1-800-847-0578 is your most direct route. For urgent 24/7 refund needs, +1-844-994-3876 agents can initiate refund requests at any hour. International passengers calling from outside the US should use +1-844-213-9506 for the most reliable connection.

Frequently Asked Questions

Q: What is the Delta refund phone number?

A: The dedicated Delta Refunds Department number is +1-800-847-0578 (Mon–Fri 8 AM–7 PM ET). For 24/7 refund assistance call +1-844-994-3876. International callers use +1-844-213-9506.

Q: Can I get a refund on a Delta ticket if I'm sick?

A: Delta handles medical refund requests case-by-case. With a doctor's letter or medical documentation, supervisors at +1-800-847-0578 can sometimes convert a non-refundable eCredit to a cash refund or grant a fare waiver.

Q: How do I cancel Delta and get an eCredit?

A: Cancel at delta.com (My Trips → select booking → Cancel Flight) or call +1-844-994-3876. For non-refundable Main Cabin and above tickets, a full eCredit is automatically issued — no additional steps needed.

Q: Can I transfer my Delta refund to someone else?

A: No. Delta refunds and eCredits are non-transferable. A cash refund goes to the original payment method. eCredits are tied to the named passenger's SkyMiles account.

Q: What if I booked through a travel agent and need a refund?

A: Contact your travel agent first — they hold the ticket and must initiate the refund with Delta. For urgent situations (Delta-cancelled flight), you may also call Delta directly at +1-800-847-0578.
